The battle is not over: Rising infections seen worldwide

THE NUMBER OF global coronavirus cases continued to surge Tuesday in many large countries that have been lifting lockdowns, including the U.S., even as new infections stabilised or dropped in parts of Western Eu-

India has been recording about 15,000 new infections each day, and some states Tuesdaywere considering fresh lockdown measures to try to halt the spread of the virus in the nation of more than 1.3 billion. The government earlier lifted a nationwide lockdown in a bid to restart the ailing economy, which has shed millions of jobs.

Hospitals in Pakistan are turning away patients, but with the economy there teetering, the government remains determined to reopen the country.

New cases have also been rising steeply in Mexico, Colombia and Indonesia. Brazil, with more than 1.1 million cases and 51,000 deaths, has been affected more than anywhere but the US, which has reported more than 2.3 million cases and 120,000 deaths, according to a tally kept by Johns Hopkins Uni-

versity. In the U.S., surges in cases across the South and West are raising fears that progress against the virus is slipping away, as states reopen and many Americans resist wearing masks and keeping their distance from

others. On Tuesday, Dr. Anthony Fauci will return to Capitol Hill at a fraught moment in the nation's response. The government's top infectious disease expert will testify before a House committee.

His testimony comes after President Donald Trump said at a weekend rally in Oklahoma that he had asked administration officials to slow down testing, because too many positive cases are turning up. Many rally goers did not wear masks, and for some that was an act of defiance against what they see as government intrusion. White House officials later tried to walk back Trump's comment on testing, suggesting it wasn't meant to be taken literally.

Dr. Michael Ryan, the World Health Organization's emergencies chief, said the record number of new cases couldn't be explained by increased testing alone, noting many countries have seen large increases in hospital admissions and deaths. "The epidemic is now peaking or moving towards a peak in a number of large countries," he said.

WHO Director-General Tedros Adhanom Ghebreyesus said it took more than three months for the world to see 1 million confirmed infections, but just eight days to see the most recent 1 million cases.

SPURRED BY NATIONWIDE protests and calls to end systemic racism after the police killing of George Floyd, Google and Facebook Inc. recently vowed to increase the diversity of their workforce. If this sounds depressingly familiar, that's because it is. The industry has been making similar pledges for

years, with little progress. The world's most valuable tech companies are still predominantly white and male, according to a Bloomberg News analysis of diversity reports published by Google, Facebook, Microsoft Corp., Apple Inc. and Amazon.com Inc. Photos of Black workers feature prominently in these reports but remain mostly absent from management ranks and are underrepresented in technical roles. Photos of leadership ranks pictured here are based on named executive officers listed in the companies' latest annual

proxy statements. If tech firms really want to increase representation, they must do more, Black employees and corporate diversity experts say. That means hiring diverse talent into higher levels of management and creating a work-

Satellite launch aims for raised scrutiny of methane emitters

ENERGY AND COMMODITY producers releasing methane into the atmosphere will face increased scrutiny with the launch of the first satellite claiming the ability to monitor individual culprits.

Iris — a microwave-sized gadget set to be launched into orbit from French Guiana this weekend, weather permitting — will be able to track methane released from oil and gas wells, coal mines, power plants, farms and factories around the globe, Stephane Germain, chief executive officer of Montreal-based developer GHGSat Inc., said in an interview.

to curb its emissions of methane, one of the most harmful gases for the atmosphere. Enough of the gas leaked from the Permian Basin oilfields in West Texas and New Mexico to heat more than 7 million homes, an April study from Harvard University and Environmental Defense Fund showed.

Iris is equipped with an enhanced spectrometer that will be able to quantify emissions by site, company and across supply chains, Germain said.

GHGSat has received a request to help determine if it's greener to import natural gas into Europe or burn coal in the continent's old power plants, he

The satellite will cover the surface of the earth every two

weeks, Germain said. GHGSat plans to have 10 satellites of this kind up by the end of 2022 to increase the frequency of the data it provides.

"Methane currently is not directly measured across the globe, and what is not measured will not be fixed," said Pratima Rangarajan, CEO Of OGCI Climate Investments, a minority investor in GHGSat through its more than \$1 billion fund managed by an oil and gas industry group. This satellite should "help bring actionable data to the world," she said.
